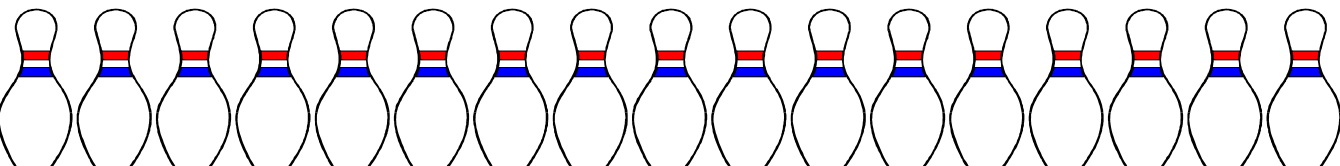

TOURNAMENT RULES

- 1) **Eligibility:** Only current members of the Nation's Capital Area Bowling Association and/or the Washington, D.C. Area Women's Bowling Association are eligible to bowl in this tournament. Non-members living within the jurisdiction of these associations who are not members of another association may enter by paying affiliate membership fee of \$16.00 (ABC) or \$25.00 (WIBC). Payment of co-association fees for membership will not be accepted at the tournament site.
- 2) Tournament will be a Scratch Doubles event consisting of three (3) games. **A person may re-enter but only cash once with the same partner.**
- 3) Each team must consist of one (1) member who has bowled an ABC 700 series and one (1) member who has bowled a WIBC 600 series at time of check-in.
- 4) Check-in time is not later than 30 minutes prior to the start of the squad. Any player arriving after the game has started will be allowed to bowl, and score(s) will count beginning in the frame being bowled. Zeroes will be given for frames missed.
- 5) Entry fee will be \$65 per team for "Early Bird" entry and must be submitted with the entry form. The fee covers \$46.00 prize fund, \$15.00 lineage, and \$4.00 expense fee. "Walk-in" fee will be \$65.00 per team plus a \$10.00 late processing fee for a total of \$75.00. Re-entry into another squad will be \$65.00 per team. **A person may only cash once with the same partner.** A \$20.00 administrative fee plus bank charges will be added to all returned checks. **CASH ONLY — DAY OF THE TOURNAMENT.**
- 6) Prize money will be returned at least 1-in-10 to the teams with the highest scores. Prize money will be returned 100%.
- 7) Walk-ins will be accepted no later than 30 minutes before the scheduled squad time of bowling—if lanes are available.
- 8) Automatic scorers will be official during the progress of the game, and scores will be entered on the official score sheets by the bowler. Scores lost due to malfunction of automatic scorers shall be re-bowled.
- 9) ABC/WIBC Rule 330 will apply. (A bowler must use the same hand to deliver the bowling ball throughout the tournament.)
- 10) A \$500.00 bond will be awarded for the first completed 300 game bowled in tournament play. Only one bond will be issued. Tournament director's decision is final.
- 11) An optional singles event will use the scores bowled in the doubles to determine the winner. There will be a male division and a female division. Entry fee is \$5.00 per bowler each squad, with all monies going to the prize fund. Prize money will be paid out at least 1-in-10. Prize fund will be returned 100%. A person may bowl in this event more than once. Only highest score bowled will count for event.
