Larry Gonzales elected president

Members choose Willie Graves Jr., Hazel Wallace, and Susan Ryan for VP posts

March 19, 2015 — Nation's Capital Area USBC Association (NCAUSBCA) members attending the Ninth Annual Membership Meeting held Sunday at

Bowl America Gaithersburg elected Larry Gonzales, Fort Washington, Md., for a one-year term as president beginning August 1, 2015. Gonzales, currently the first vice president who lost to Gene Mays, Washington, D.C., in the 2014 presidential balloting, ran unopposed.

This election began the "staggered terms" procedure approved last year for executive board positions. Larry Gonzales will serve as NCAUSBCA president for the 2015-2016 season.




